

OUR WORK AND HOW WE CONTRIBUTE TO THE



ZAMBEZI CONSERVATION STORY

Since ZEF began, 8 short years ago, our primary role has been to support organisations doing bona fide conservation work in the Zambezi Valley deliver optimal impact. Those that need financial help to do the work they do more effectively, apply to us for funding and each year we do all we can to provide them with the support they need to make a measurable difference to their operations.

Our secondary role has been to assist with providing human and financial resources to promote the preservation of elephants in the landscape through wider policy, management and economic stability; only possible through the efforts of our team who are uniquely placed to add their authentic advisory.

The purpose of this report is to describe the variety of activities that ZEF helps deliver and to bring our donors and supporters closer to the detail of our work, our impact, and our ambition.







A MESSAGE



A Message From Our Co-founder: RICHARD MAASDORP

Together with my fellow founders, John and Nicci Stevens, I thank our wide range of donors for their generous and considered support. It is also important to note that with your support our implementing partners leverage on the funding they receive from ZEF to secure co-funding for their projects. This leverage from ZEF funding so often goes unrecognised.

Although there has been a drop in poaching across much of Africa, said to be due to the fall in the price of ivory, I urge donors and our ZEF team to continue to fund the fundamental activity of law enforcement. The dynamics around ivory are both fickle and varied. The assault on elephants could resume overnight. I am pleased that all ZEF partners work closely with the custodians of Zimbabwe's elephant – Zimbabwe Parks and Wildlife Management Authority – in pursuit of continual development of the ranger force.



We should all be proud of the continued innovation that our Zambezi conservation partners add to the advances in conservation we see in Zimbabwe.

- A 12km elephant proof fence erected in a very short time to surround and protect a highly vulnerable community.
- A virtual wildlife safari using virtual reality technology for school students in the communities. (I have witnessed, with goose bumps, the excitement of our future benefactors, as they watch the scenes with awe and wonder.)
- The application of science to pinpoint conflict hot spots so that mitigation methods can be deployed with precision and affected villages trained in their use.
- The successful testing and now roll-out of the latest camera and recording methods to conduct aerial surveys using light sports aircraft. (Reducing the costs of surveys dramatically, producing results promptly and allowing for annual surveys.)
- Finally, the planting of fast growing, indigenous trees by the villagers who earn a modest income and take ownership. Decimated bio-diversity is systematically being recovered.

HOW ZEF OPERATES

The Zambezi Elephant Fund (ZEF) was formed and began activity in 2015 as a response to an unprecedented increase in elephant poaching within the Zambezi Valley of Zimbabwe.

ZEF's immediate aim, back then, was to assist the reduction of elephant losses, through improvements to anti-poaching operations that have since advanced to provide a greatly improved scenario for both elephants and all wildlife.

Today, we still focus a large proportion of funding and energy into the protection of elephant, wildlife and habitat that is under threat, whilst also supporting human wildlife issues and the economic resilience of local communities.



OPERATIONS



THE TEAM

Our team in 2022 has included one full time and two part time staff members who have managed the fundraising, communications, in-field project development, partner programming and financial tracking needs.

Assisting this team are our advisors, founders John & Nicci Stevens and Richard Maasdorp, who are closely involved with guiding ZEF's operational success.

GOVERNANCE AND ETHICS

In step with the attributes of those that first put the organisation together, ZEF does everything possible to maintain a characteristic of authentic conservation. This trait continues to those entities who receive support from ZEF; our partners in the landscape, with whom we maintain a close relationship and ensure a strong culture of safeguarding, operating standards, efficiencies and ethics.

Overseeing the governance of the Trust, our trustees meet twice annually.


THE WAY WE MANAGE OUR FINANCES

ZEF has benefited enormously, since its inception, by the fiscal sponsorship of USA based international conservation organisation, Re:wild (formerly Global Wildlife Conservation). This relationship has allowed for tax deductible donations to be kept for us under their supervision, to be then drawn down to Zimbabwe for in field operations when needed. We are grateful for Re:wild's continued support, both from a financial management perspective, but also in their ability to link donors to the cause of the Zambezi Valley.

2022 EXPENDITURE ANALYSIS




- From 2022, we are no longer reporting on restricted funding held on behalf of other organisations/programs, which amounts to \$697,550.23 in 2022.
